## **PURPOSE OF THIS PRIVACY NOTICE**

This privacy notice aims to give you information on how SkyBlue collects and processes your personal data through your use of this website, including any data you may provide through this website when you submit your curriculum vitae ('CV') to apply for a permanent, temporary or contract position with or through SkyBlue, when you express an interest in working for or through us or when you sign up to our newsletter or when you purchase services from us.

This website is not intended for children and we do not knowingly collect data relating to children.

It is important that you read this privacy notice together with any other privacy notice or fair processing notice we may provide on specific occasions when we are collecting or processing personal data about you so that you are fully aware of how and why we are using your data. This privacy notice supplements the other notices and is not intended to override them.

## 2. THE DATA WE COLLECT ABOUT YOU

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

We may collect, use, store and transfer different kinds of personal data about you which we have grouped together follows:

- **Identity Data** includes first name, maiden name, last name, username or similar identifier, marital status, title, date of birth, right to work information, referees, electronic signature and gender.
- Contact Data includes billing address, home address, email address and telephone numbers.
- Financial Data includes bank account and where required payment card details.
- Transaction Data includes details about payments to and from you and other details of products and services you have purchased from us.
- Technical Data includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform and other technology on the devices you use to access this website.
- Profile Data includesyour username and password, work history, your interests, preferences, feedback and survey responses.
- Usage Data includes information about how you use our website, products and services.
- Marketing and Communications Data includes your preferences in receiving marketing from us and our third parties
  and your communication preferences.

We also collect, use and share Aggregated Data such as statistical or demographic data for any purpose. Aggregated Data may be derived from your personal data but is not considered personal data in law as this data does not directly or indirectly reveal your identity. For example, we may aggregate your Usage Data to calculate the percentage of users accessing a

specific website feature. However, if we combine or connect Aggregated Data with your personal data so that it can directly or indirectly identify you, we treat the combined data as personal data which will be used in accordance with this privacy notice.

For the purposes of monitoring equality and inclusion we may collect, where you have disclosed as such, Special Categories of Personal Data about you (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health and genetic and biometric data). We may also collect information about criminal convictions and offences which are unspent or where relevant to the role (such as working with vulnerable adults or children) previous criminal offences that are required, by law, to be disclosed to us.

#### IF YOU FAIL TO PROVIDE PERSONAL DATA

Where we need to collect personal data by law, or under the terms of a contract we have with you and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example, to provide you with work finding services).

### 3. HOW IS YOUR PERSONAL DATA COLLECTED?

We use different methods to collect data from and about you including through:

- **Direct interactions.** You may give us your Identity, Contact and Financial Data by filling in forms or by corresponding with us by post, phone, email or otherwise. This includes personal data you provide when you:
  - apply for position with or through us;
  - create an account on our website;
  - subscribe to our service or publications;
  - request marketing to be sent to you;
  - enter a competition, promotion or survey; or
  - · give us some feedback.
- Automated technologies or interactions. As you interact with our website, we may automatically collect Technical
  Data about your equipment, browsing actions and patterns. We collect this personal data by using cookies, and other
  similar technologies.
- Third parties or publicly available sources. We may receive personal data about you from various third parties as set out below:
  - Technical Data from the following parties:
- (a) analytics providers such as Google: and
- **(b)** advertising networks such as Job boards, the Job Centre or other 3<sup>rd</sup> parties where you have registered your CV for work finding services.

# 4. HOW WE USE YOUR PERSONAL DATA

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract we are about to enter into or have entered into with you.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal or regulatory obligation.

Generally we do not rely on consent as a legal basis for processing your personal data other than in relation to sending third party direct marketing communications to you via email or text message. You have the right to withdraw consent to marketing at any time by contacting us.

# PURPOSES FOR WHICH WE WILL USE YOUR PERSONAL DATA

We have set out below, in a table format, a description of all the ways we plan to use your personal data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.

Note that we may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data. # **MARKETING**

We strive to provide you with choices regarding certain personal data uses, particularly around marketing and advertising:

# **WORK FINDING SERVICES FROM US**

We may use your Identity, Contact, Technical, Usage and Profile Data to form a view on what we think you may be of interest to you. This is how we decide which services and career opportunities may be relevant for you.

You will receive communications from us if you have requested information from us.

# THIRD-PARTY MARKETING

We will get your express opt-in consent before we share your personal data with any company outside the SkyBlue group of companies for marketing purposes.

#### **OPTING OUT**

You can ask us or third parties to stop sending you marketing messages at any time by logging into your account and checking or unchecking relevant boxes to adjust your marketing preferences or by contacting us at any time.

Where you opt out of receiving these marketing messages, this will not apply to personal data provided to us as a result of work finding services or when you have a current assignment through us.

### **COOKIES**

You can set your browser to refuse all or some browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of this website may become inaccessible or not function properly.

#### **CHANGE OF PURPOSE**

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If you wish to get an explanation as to how the processing for the new purpose is compatible with the original purpose, please contact us.

If we need to use your personal data for an unrelated purpose, we will notify you and we will explain the legal basis which allows us to do so.

Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

#### 5. DISCLOSURES OF YOUR PERSONAL DATA

We may have to share your personal data with the parties set out below for the purposes set out in the table in paragraph 4 above.

- Internal Third Parties as set out in the [Glossary].
- External Third Parties as set out in the [Glossary].
- Third parties to whom we may choose to sell, transfer, or merge parts of our business or our assets. Alternatively, we may seek to acquire other businesses or merge with them. If a change happens to our business, then the new owners may use your personal data in the same way as set out in this privacy notice.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

# 6. INTERNATIONAL TRANSFERS

We do not transfer your personal data outside the European Economic Area (EEA).

#### 7. DATA SECURITY

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

#### 8. DATA RETENTION

#### HOW LONG WILL YOU USE MY PERSONAL DATA FOR?

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature, and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal requirements.

Details of retention periods for different aspects of your personal data are available in our retention policy which you can request from us by contacting us.

### 9. YOUR LEGAL RIGHTS

Under certain circumstances, you have rights under data protection laws in relation to your personal data, they are:

#### The right to object:

This right enables you to object to us processing your personal data where we do so for one of the following 4 reasons:

- 1) Because it is within our legitimate interests;
- To enable us to perform a task in the public interest or exercise official authority;
- 3) To send you direct marketing materials; and
- 4) For historic, research or statistical purposes

The legitimate interests category above is the one most likely to apply in relation to our services to you and our recruitment processes, and/if your objection relates to us processing your personal data because we deem it necessary for our legitimate interests, we must act on your objection by ceasing the activity in question unless:

- 1) We can demonstrate that we have compelling legitimate grounds for processing which overrides your interests; or
- 2) We are processing your data for the establishment, exercise or defence or a legal claim

# The right to withdraw consent:

Where we have obtained your consent to process your personal data for certain activities you may withdraw this consent at any time and we will cease to carry out that particular activity that you previously consented to unless we consider that there is an alternative legal basis to justify our continued processing of your data for this purpose, in which case we will inform you of this.

# The right to submit a data subject access request (DSAR):

You may ask us to confirm what information we hold about you at any time and request us to modify, update or to delete such information. We may ask you for more information about your request. If we provide you with access to the information we hold about you, we will not charge you for this unless your request is 'manifestly unfounded or excessive'. If you request further copies of this information from us we may charge you a reasonable administrative fee where we are legally permitted to do so. Where we are legally allowed to refuse your request we will tell you the reasons for doing so.

### Right to erasure:

You have the right to request that we erase your personal data in certain circumstances. Normally such a request to erase information must meet one of the following criteria:

- 1) The data is no longer necessary for the purpose for which we originally collected and/ or processed it;
- 2) Where previously given you have withdrawn your consent to us for processing your data and there is no other valid reason for us to continue to process it;
- 3) The data we hold on you has been processed unlawfully (for example not in compliance with the General Data Privacy Regulations;
- 4) It is necessary for the data to be erased in order for us to comply with our obligations as a data controller under EU law or UK law (as applicable at the time); or
- 5) In processing your data because we believe it necessary to do so for our legitimate interests you object to the processing and we are unable to demonstrate an overriding legitimate ground for our continued processing.

We are able to refuse your request to erasure for one of the following reasons:

- 1) To exercise the right of freedom of expression and information;
- 2) To comply with a legal obligation or for the performance of a public interest task or exercise of official authority;
- 3) For public health reasons in the public interest;
- 4) For archival research or statistical purpose; or
- 5) To exercise or defend a legal claim.

# Right to restrict processing:

You have the right to request that we restrict our processing of your data in certain circumstances. This means that we can only continue to store your data and will not be able to carry out any further processing activities with it until either:

- 1) One of the circumstances listed below is resolved;
- 2) You consent; or
- 3) Further processing is necessary for either the establishment, exercise or defence of legal claims, the protection of the rights of another individual or reasons of important EU or UK (as appropriate) public interest.

The circumstances in which you are entitled to request that we restrict the processing of your data are:

- 1) Where you dispute the accuracy of the data that we are processing about you. In which case our processing of your data will be restricted for the period during which the accuracy of the data is verified;
- 2) Where you object to our processing of your personal data for our legitimate interests. In which case you can request that the data be restricted while we verify our grounds for processing your data;
- 3) Where our processing of your data is unlawful but you would prefer us to restrict our processing of it rather that erasing it; and
- 4) Where we have no further need to process your data to establish, exercise or defend legal claims.

If we have shared your data with third parties we will notify them about the restricted processing unless this is impossible or involves disproportional effort. We will notify you before lifting any restriction on processing of your data.

## Right to rectification:

You have the right to request that we rectify any inaccurate or incomplete data that we hold about you including by means of providing a supplementary statement. If we have shared this data with third parties we will notify them about the rectification unless this is impossible or involves disproportionate effort. You may also request details of the third parties that we have disclosed the inaccurate or incomplete data to. Where we believe it is reasonable for us not to comply with your request we will explain our reasons for this.

## Right of data portability:

If you wish you have the right to transfer your data between data controllers. This means you are able to transfer the details that we hold on you to another potential employer or a third party. To allow you to do so we will provide you with your data in a commonly used machine readable format so that you can transfer the data, alternatively we may directly transfer the data for you. This right applies only to:

- 1) Personal data that we process automatically (i.e. without human intervention;
- 2) Personal data provided by you; and
- 3) Personal data that we have processed based on your consent or in order to fulfil a contractual obligation.

Right to lodge a complaint with a supervisory authority:

You have the right to lodge a complaint with your local supervisory authority. Details of local supervisory authorities are provided below:

## 10. GLOSSARY

### **LAWFUL BASIS**

Legitimate Interest means the interest of our business in conducting and managing our business to enable us to give you the best service and the best and most secure experience. We make sure we consider and balance any potential impact on you (both positive and negative) and your rights before we process your personal data for our legitimate interests. We do not use your personal data for activities where our interests are overridden by the impact on you (unless we have your consent or are otherwise required or permitted to by law). You can obtain further information about how we assess our legitimate interests against any potential impact on you in respect of specific activities by contacting us.

**Performance of Contract** means processing your data where it is necessary for the performance of a contract to which you are a party or to take steps at your request before entering into such a contract.

Comply with a legal or regulatory obligation means processing your personal data where it is necessary for compliance with a legal or regulatory obligation that we are subject to.

# **INTERNAL THIRD PARTIES**

# **EXTERNAL THIRD PARTIES**
